INDEPENDENT AUDITORS REVIEW REPORT

To
THE BOARD OF DIRECTORS OF

We have reviewed the accompanying Statement of Unaudited Financial Results ('the Statement') of **ALPINE COMMERCIAL COMPANY LTD.** ('the Company'), for the Quarter ended 30th June, 2019. The Statement has been prepared by the Company pursuant to Regulation 33 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "Listing Regulations, 2015"), as modified by Circular No. CIR/CFD/FAC/62/2016 dated 5th July, 2016. This Statement is the responsibility of the Company's Management and has been approved by the Board of Directors, has been prepared in accordance with recognition and measurement Principles laid down in the Indian Accounting Standard 34 "Interim Financial Reporting" ("IND AS 34"), prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to issue a report on these financial statements based on our review.

We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410, 'Review of Interim Financial Information performed by the Independent Auditor of the Entityissued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free from material misstatement. A review is limited primarily to inquire of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

Regarding Provision for Deferred Taxes and Provision for Income Tax in terms of 'Accounting for taxes on income' IND AS -12, the management opined that these cannot be ascertained at this stage and will be accounted for at the end of the year.

Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying Statement of Unaudited Financial Results prepared in accordance with applicable Indian Accounting Standards (Ind AS) and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "Listing Regulations, 2015"), as modified by Circular No. CIR/CFD/FAC/62/2016 dated 5th July, 2016 including the manner in which it is to be disclosed, or that it contains material misstatement.



We draw attention to Note 6 to the financial results which state that figures for the quarter ended on 30.06.18 does not includes the figures of Sunshine Niwash Private Limited (Transferor Company) as the same is now merged with the Company pursuant to Scheme of arrangement of amalgamation of , duly approved by Hon'ble RD (ER), West Bengal, vide order dated 18th August, 2018 from appointed date 01.04.2016, and hence the same is not comparable.
